To aid and grant loans and donations may be collected from the public bodies, Governments and Trusts having common causes, from outside else.

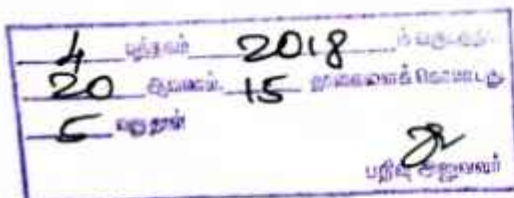
To aid and grant loans and donations to the Government or any statutory to help them enforcement of such activities and objectives similar to the Trust, whether inside or outside India.
